Draft material reply to Rajya Sabha Unstarred Question D. No. 3775, 1648 & 650 for answer on 10.12.2015 asked by Smt. Kanak Lata Singh and Shri Vishambhan Prasad Nishad regarding "Fraud cases for jobs in Jawaharlal Nehru University".

Q. (a) Whether it is a fact that a case of fraudism with people for giving jobs in Jawaharlal Nehru University has come to light;

Reply (a): No. However, a letter of complaint was received through MHRD letter dated 19.05.2015 against one of the Group 'C' employees, working as Khalasi.

Q. (b) If so, the action taken in such case of allegation of fraudism for giving job in such a prestigious University; and

Reply (b): The above said individual has been suspended w.e.f. 20.10.2015 pending enquiry.

Q. (c) The details thereof?

Reply (c): After receipt of a complaint, the case has been forwarded to Chief Vigilance Officer. A Fact Finding Committee was constituted to inquire into the complaints received against the individual. According to the report of the Fact Finding Committee and recommendation of Legal Cell, the employee has been suspended from the University pending enquiry. A charge sheet has been served to him and an Inquiry Committee has also been constituted. A request to lodge FIR against the employee has also been submitted to the S.H.O., Vasant Kunj (North) Police Station, New Delhi on 29.09.2015.
