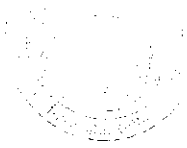

- (ii) On every first Wednesday of each month, Maurice Nagar Police Station is arranging Delhi University Area Security Committee mtg. at Kirori Mal College to provide a platform to raise issue only pertaining to the safety and security of North-East students of Delhi University and the suggestions pointed out by the representatives of North-East are taken care of as a preventive measures for the safety and security of these students.
