1.	2300032888	<p><u>Criteria 2:</u> Candidate has claimed 9 articles only. Out of the total 9 claimed, <u>none can be accepted</u> since 2 are (one page) opinion papers published in magazines, 5 are published in Andhra Law Times and 1 in Supreme Court Law Journal. These are primarily judgment reporters - not academic journals. Hence they cannot be accepted as research publications. <u>Does not meet Criteria 2.</u></p> <p><u>Criteria 4:</u> The candidate has claimed a total of 27 years of experience in the Ministry of Law and Justice holding administrative positions (such as a Legal Assistant and a Legal Advisor). <u>These are NOT teaching and/or research positions required</u> for the post. Candidate has NO teaching and/or research experience.</p> <p><u>Criteria 6:</u> Candidate does not have the experience of doctoral supervision.</p>
2.	2300032821	<p><u>Criteria 2:</u> Candidate has claimed 13 articles. But <u>only 8 can be accepted</u> (rejected 5 include 1 book review and 4 others published in judgment reporters (Labour and Industrial Cases, Supreme Court Cases, Criminal Law Journal, All India Reporter). Does not have the required minimum 10 research publications.</p> <p><u>Criteria 6:</u> Candidate does not have an experience of doctoral supervision.</p>
3.	2300033194	<p><u>Criteria 2:</u> Candidate has claimed only 8 publications. Does not meet Criteria 2.</p> <p><u>Criteria 5:</u> Candidate's research and teaching experience are (in the field of Political Science) <u>not in International Law.</u></p> <p><u>Criteria 6:</u> Candidate does not have the experience of doctoral supervision.</p>
