


- i. Enhance office efficiency.

  - iii. Reduce paper-work.
  - iv. Prevent fraud and mis-appropriation of public funds.
  - v. Enhance effectiveness in management of schemes, grants, budget and finances.
  - vi. Establish reliable MIS for monitoring functioning of higher education the country.
2. For this, UGC has developed 'eschemes' portal, link for which is available at UGC website [www.ugc.ac.in](http://www.ugc.ac.in). Your institution may like to be a part of new initiative of UGC and apply under various schemes directly through web enabled service.
  3. To be able to apply under this mode, your institution is required to register itself. It is desired that only one officer of the level of Registrar registers himself/herself on behalf of the institution. Once the registration process is complete the user will be able to log-in only after UGC has activated the ID of user. It may be noted that only one registration is allowed per institution.
  4. Before you initiate the process of registration, kindly keep ready (i) scanned copy of official ID card (both sides) and (ii) scanned copy of this letter. If the authorities feel that some other officer may register on behalf of your institution, an authority letter may be issued in his/her name and a scanned copy may also be kept ready for uploading along with other two above mentioned documents.
