- (a) **Whether the Ministry has issued any direction for creation of two seats under supernumerary Quota for Students from Jammu and Kashmir who seek admission through centralized counselling in Universities /Colleges approved under section 2(f) and 12B of UGC Act or recognized by AICTE and have at least one National Board of Accreditation (NBA) approved course.**

Reply: It is for MHRD to respond. However, Supernumerary quota for students from Jammu and Kashmir is implemented in JNU as under:-

Out of 02 seats, 01 seat will be allocated for B.A. programme and another 01 seat for M.A. programme. The candidates for these seats will be selected on the basis of securing highest marks among the non-shortlisted candidates in the merit & qualified otherwise.
