**(a) Whether the Government is aware that there are vacant faculty positions in Jawaharlal Nehru University (JNU) and if so, the details thereof;**

Reply: The details of vacant faculty positions are as given below:

Professor	: 96
Associate Professor	: 125
Assistant Professor	: 87
<b>Total</b>	<b>: 308</b>

**(b) Whether the Government has any proposal to fill the vacant faculty posts in the near future and if so, the details thereof;**

Reply: The University has already advertised 19 faculty positions reserved for Persons with Disabilities vide Rolling Advt. No. RC/01/2016 in September, 2016. Out of the 19 faculty positions, the University has already selected 02 candidates and the recruitment process for other vacancies is under way.

Around 91 faculty positions reserved for Scheduled Castes & Scheduled Tribes have also been advertised vide Rolling Advt. No. RC/02/2016 in November, 2016. The screening process of the applications is under way.

Around 98 faculty positions i.e. Unreserved & Reserved for OBC will be published in the Employment News on 11 February, 2017. Recruitment for these positions would be started as soon as possible after the last date for submission of applications on 14 March, 2017
