Draft material reply to the Rajya Sabha Provisionally Admitted Starred/Unstarred Question Diary No. S309 for 02.02.2017 asked by Shri Ritabrata Banerjee regarding "enquiry into missing of JNU student".

Q. (a) Whether it is a fact that till date there is no trace of Najeeb, the student of JNU who got missing from the campus, if so, the details thereof;

Reply (a): Yes, it is a fact that Mr. Najeeb Ahmed (Regn. No.200492, Enrolment Number: 16/71/JB/022, Year of admission: 2016, an M.Sc. student of School of Biotechnology and resident of Mahi Hostel) left his hostel on 15th October, 2016 without informing his Sr. Warden/seniors. Till date he has not returned to his hostel.

Q. (b) What actions are initiated in this regard; and

Reply (b): On the directions of the Hon'ble High Court Order, the Crime Branch and Police carried out a search operation in JNU Campus without any hindrance regarding missing student of JNU.

Q. (c) Whether there was any attack on him inside the campus, if so, the details thereof?

Reply (c): A three member Proctorial Enquiry Committee was constituted to investigate this matter. The Committee called various students, witnesses, JNU security personnel etc. for hearing before the Proctorial Enquiry Committee. On the recommendation of the Committee, the following students who were involved in the scuffle with Mr. Najeeb Ahmed in Mahi-Mandavi Hostel on 14th October, 2016 were transferred to other Hostels:-

- 1) Mr. Vijendra Thakur (a B.A. student, Centre of Russian Studies, School of Language, Literature & Culture Studies and resident of 31, Mandavi Hostel).
- 2) Mr. Ashwary Pratap Singh (an M.A. student, Centre of Persian and Central Asian Studies, School of Language, Literature and Culture Studies and resident of 226, Chandrabhaga Hostel).
- 3) Mr. Ankit Kumar Roy (a B.A. student, Centre of Russian Studies, School of Languages, Literature & Culture Studies and resident of 214, Mahi Hostel).
- 4) Mr. Vikrant Kumar (a B.A. student, Centre of Russian Studies, School of Language, Literature & Culture Studies and resident of 213, Mahi Hostel).
