It may also be noted that in the event of re-allocation of work among the officers in the University from time to time, the incumbent officers shall automatically act as CPIO/Appellate Authority in respect of their work. No separate and specific orders in this regard will be necessary in so far work relating to RTI is concerned.

In case of absence of designated Officer, due to his/her proceeding on leave, tour, training, transfer, suspension or any other reasons, the concerned Officer holding the additional charge will receive, process and dispose off all on-line and off-line RTI applications, appeals, notices for hearing in CIC etc.

Shri M K Pachauri, Joint Registrar (Admissions) (Tel: 011-26704047) will be the Nodal CPIO under Section 5(2) of the RTI Act, 2005. Nodal CPIO's role is limited to coordination

work. RTI applications will be directly dealt by the concerned CPIO(s) and reply should be sent directly to the applicant. In case of an appeal, it should be dealt directly by the concerned Appellate Authority, as per provision of RTI Act, 2005.

The RTI applications in respect of School of Engineering (SoE) and Atal Bihari Vajpayee School of Management and Entrepreneurship (ABVSME) will be directly dealt by RTI Cell itself. If any School/department is left out in the above said list, the RTI applications pertaining to such sections/departments shall be continued to be dealt by RTI Cell, till further arrangements are made.
