1.	2300033008	<p><b>Criteria 2:</b> Candidate has claimed 9 publications, but only two of them can be accepted. <b>6 out of total 9 publications are rejected because they have been published in journals whose credentials are suspicious.</b> These journals are <b>paid journals</b> wherein authors are expected to pay publication charges or manuscript processing charges ranging from Rupees 800 to 1600. <b>2 have been published in 'predatory journals'.</b> <b>Thus 7 publications (out of total 9) cannot be considered as scholarly publications and therefore cannot be accepted.</b> Does not meet criteria 2. <b>Note:</b> Candidate does not meet Criteria 6 (desirable)</p>
2.	2300032365	<p><b>Criteria 1:</b> Candidate has Ph.D. in Public Policy, <b>not in international law</b> or related discipline-Does not meet criteria 1. <b>Criteria 2:</b> Candidate <b>does not have minimum 7 publications in peer reviewed journals</b>-Does not meet criteria 2. <b>Criteria 3:</b> Candidate <b>does not have 8 years of research and</b> teaching experience relevant to the field of international law-does not meet criteria 3. <b>Note:</b> Candidate does not meet Criteria 6 (desirable)</p>
