
(The Net DISTRESS = Distress Level –Comfort Level)

The details of the compassion Index are as follows:

<u>S. No.</u>	<u>Net distress</u>	<u>Degree of Distress</u>
1.	More than 50	Extreme
2.	26-50	Moderate
3.	upto 25	Comfortable

The Standing Committee on the basis of the above tabulation recommends that since all the applicants fall under the Comfortable Category and do not meet the objective of the compassionate appointment, their candidature for appointment on compassionate ground cannot be considered. The Committee also recommends that the net distress point may be notified on the University website for information of all concerned.


