Draft material for reply to Lok Sabha Unstarred Question No. 2839 for 20.03.2017 regarding 'Safety of students in Campuses'

Q. (a) The details of incidents of unrest in Jawaharlal Nehru University Campus during the last two years.

Reply: The following incidents of unrest were held in Jawaharlal Nehru University Campus during the last two years:

- Due to a Programme organized by some students of the University on 09.02.2016 near Sabarmati and Ganga Hostel.
- On missing of Mr. Najeeb Ahmed, a student of School of Biotechnology (M.Sc.) (Regn. No.200492, Enrolment Number: 16/71/JB/022, Year of admission: 2016, and resident of Mahi Hostel) from 15<sup>th</sup> October, 2016, the Student Union of the University gave a call to "join National call of Chalo JNU, Juloos and Protest Gathering" on 15<sup>th</sup> November, 2016 at 3:00p.m. Its subject was "Najeeb missing from JNU after Being Assaulted". Around 200 people participated in it. The protest started from Ganga Dhaba and finally terminated at Administrative Block of the University where some slogans shouting and speeches took place.
- Due to adoption of UGC Regulation of May 5, 2016 published in Gazette of India on July 5, 2016 relating to award of M. Phil and Ph.D. degree in terms of UGC (Minimum Standards and Procedure for Award of M. Phil. / Ph.D. Degree) Regulation 2016.
- Q. (b) Whether it is a fact that one of the student of the University has gone missing and could not be traced up till now and if so, the details thereof; and
- Reply: Yes, it is a fact that Mr. Najeeb Ahmed (Regn. No.200492, Enrolment Number: 16/71/JB/022, Year of admission: 2016, an M.Sc. student of School of Biotechnology and resident of Mahi Hostel) left his hostel on 15<sup>th</sup> October, 2016 without informing his Sr. Warden/seniors. Till date he has not returned to his hostel. Najeeb's case has been taken up by the Crime Branch of Delhi Police since 11.11.2016 and all details of the case are with the Delhi Police.
- Q. (c) The steps taken by the Government for the safety of students in Central Universities?

Reply: It is for MHRD to respond.
