About The Program

The conference aims to establish an alternative paradigm of International Relations by deliberating upon indigenous Indian frameworks of political thought that offer distinct ways of analysing, interpreting, and engaging with global politics. Rooted in India's civilizational experience, Bharat Nīti represents a knowledge tradition in which power, leadership, and diplomacy are understood through ethical responsibility, relational conduct, and collective welfare rather than through power maximization alone. The conference proceeds from the premise that India possesses internally coherent paradigms of knowledge that can contribute meaningfully to contemporary debates on global order and international relations.

The conference invites scholarly engagement with key indigenous conceptual categories such as Mitra (ethical and trust-based relationships), Guru (moral and intellectual leadership), Shakti (capability guided by restraint), and Kalyan (collective welfare). Together, these concepts articulate a vision of global politics in which power functions as a means rather than an end, leadership derives legitimacy from conduct and example, and international engagement is evaluated through its impact on social harmony and human well-being. Bharat Nīti thus foregrounds balance, responsibility, and purpose as central principles of political action at the global level.

Spanning classical, medieval, and modern Indian thought—from early political-strategic traditions to contemporary formulations such as Integral Humanism—the conference seeks to highlight both continuity and evolution within Indian approaches to global politics. It encourages interdisciplinary participation from political science, international relations, philosophy, history, strategic studies, and Indian Knowledge Systems to explore how indigenous Indian ideas can inform discussions on global governance, strategic autonomy, normative leadership, South–South cooperation, and post-Western International Relations.

At a time of geopolitical shifts, crisis of multilateralism, and the search for post-Western frameworks in International Relations, indigenous paradigms have gained renewed significance. Bharat Nīti offers a civilizationally grounded yet analytically relevant approach to issues such as multipolarity, strategic autonomy, ethical leadership, and South–South cooperation. By emphasizing relational ethics, restrained power, and collective welfare, it contributes meaningfully to contemporary debates on global governance and alternative world orders.
