Subject: Challenge to Provisional Answer Keys wrt CBT Exam for PhD. Programme in (i) Cinema Studies, School of Arts and Aesthetics and in (ii) Korean Language, School of Language Literature and Culture Studies for the Academic Year 2025-26.

In continuation of the Entrance Examination conducted on 14.12.2025 (Sunday) from 02:00 PM to 05:00 PM, it is hereby notified for the information of all concerned candidates that the Provisional Answer Keys have been made live on the examination portal. All candidates who have appeared in the CBT Examination for Korean language and Cinema Studies held on 14th December are only eligible to submit the online challenge responses subject to the conditions mentioned here in the notice.

Challenge Window:

Candidates who wish to raise objections/challenges, if any, against the provisional answer keys may do so through the online mode only during the following period:

Start Date: 16 December 2025 (6 PM onwards)

End Date: 18 December 2025 (up to 5:59 PM)

Any challenge submitted after the above-mentioned period shall not be entertained under any circumstances.

Procedure for Raising Challenges:

The detailed Standard Operating Procedure (SOP) for submitting challenges has been provided and is available on admission portal. Candidates are advised to carefully read and strictly follow the steps outlined therein while submitting their objections. No individual communication regarding the acceptance or rejection of challenges will be made.

Challenge fees:

Candidates may challenge one or more questions.

A non-refundable fee of Rs. 250/- (Rupees Two Hundred Fifty only) shall be payable per question challenged.

The challenge fee must be paid online (through QR code) only as per the instructions available on the examination portal.

Important Instructions:

Objections can be raised only through the candidate's login on the examination portal. Candidates are advised to carefully verify the question number, question ID, and option(s) selected before submission.

Each objection must be supported with appropriate justification/documentary evidence, as prescribed in the SOP.

After final submission, no modification in the submitted objections shall be permitted. The decision of the University / subject experts on the challenges shall be final and binding.

Candidates are advised to complete the process well before the deadline to avoid last-minute technical issues and visit the examination portal regularly for updates.
