Out of the total 9 claimed, none can be accepted since 2 are (one page) opinion papers published in magazines, 5 are published in Andhra Law Times and 1 in Supreme Court Law Journal. These are primarily judgment reporters - not academic journals. Hence they cannot be accepted as research publications. Does not meet Criteria 2. Criteria 4: The candidate has claimed a total of 27 years of experience in the Ministry of Law and Justice holding administrative positions (such as a Legal Assistant and a Legal Advisor). These are NOT teaching and/or research positions required for the post. Candidate has NO teaching and/or research experience. Criteria 6: Candidate does not have the experience of doctoral supervision.

But only 8 can be accepted(rejected 5 include 1 book review and 4 others published in judgment reporters(Labour and Industrial Cases, Supreme Court Cases, Criminal Law Journal, AllIndia Reporter). Does not have the required minimum 10 research publications.Criteria 6:Candidate does not have an experience of doctoral supervision.
