A minimum of 10 research publications (no review article) in the peer-reviewed journal in the last ten years (from the last date of application) as first/corresponding author, of which at least five research publications (not reviews) should be having an impact factor 5.0 or more (Thomson Reuters/Clarivate Analytics) in any one of the above-mentioned specified areas of specialization/expertise.

vi. At least 12 years of service should be left.

vii. Having experience in implementing two (02) major research projects as the main PI.

viii. Evidence of having successfully & independently guided three (03) doctoral students as the main supervisor.
