CIRCULAR

In compliance of the Government of National Capital Territory of Delhi, DDMA Order No.60/DDMA/COVID-19/2021/500 dated 28.12.2021, the Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, Office Memorandum No. 11013/9/2014-Estt.A-III dated 03.01.2022 and in continuation of the Order of Alert (Level-I) No. 01/Admin./Corona (Covid-19)/Misc. 2020-2021 dated 29.12.2021, in view of the initial signs of surge in cases of COVID-19, and keeping in mind well being and safety of students/staff and campus residents, all stakeholders of the University are hereby requested to strictly adhere to the following measures/steps to prevent its spread in the University Campus.

1. All are requested to ensure strict compliance with Covid-appropriate behavior viz. frequent washing of hands/sanitization, wearing a mask/face cover, observing social distancing at all times.
2. Installation and use of Aarogya Setu App shall be advised to all.
3. Wearing of face mask is mandatory in the campus. The Security Personnel are authorized to take photograph, if anyone is not wearing the face mask. Appropriate disciplinary action including fine shall be imposed in this regard.
4. Avoid non-essential movements in the campus and stay safely at home.
5. The Security Personnel are instructed to barricade the sensitive area in order to restrict the non-essential movement.
6. Employees and their family members, and students who test positive or are under home isolation/quarantine, must inform with supporting documents immediately to the Security for necessary action.
7. These advisories would be applicable with immediate effect.

The Security Branch of the University is instructed to ensure strict compliance of this order, and shall adequately inform and sensitize the field functionaries about these instructions for strict compliance, in letter and spirit and all entry gates of the campus shall be closed in the curfew timings. The Chief Medical Officer (SAG), Health Centre/Chief Security Officer, Security Branch are also requested to inform the reported Covid-19 cases to the Administration by 4:00 P.M. daily.
