Subject:- 1) Celebration of 'Jan Jatiya Gaurav Diwas' from 15.11.2024 to 26.11.2024 and Jan Jatiya Gaurav Varsh from 15.11.2024 to 15.11.2025

2) Celebration of Constitution Day on 26.11.2024

Like every year this year also the University is celebrating the 04th Janjatiya Gaurav Diwas (JJGD), 2024 from 15.11.2024 to 26.11.2024, Jan Jatiya Gaurva Varsh from 15.11.2024 to 15.11.2025 and Constitution Day 2024 on 26.11.2024 to coincide with the Constitution Day.

The Jan Jatiya Gaurav Diwas celebrations will start from 15.11.2024 and leading upto 26.11.2024. Further, 150th birth anniversary of Bhagwan Birsa Munda will be commemorated next year and year-long celebrations will be held in the University from 15.11.2024 to 15.11.2025.

The list of activities to be taken up by all Departments/Schools/Centres during the celebration of 'Jan Jatiya Gaurav Diwas' from 15.11.2024 to 26.11.2024 and Jan Jatiya Gaurav Varsh from 15.11.2024 to 15.11.2025:-

- 1) Floral tributes in the education institutions and hostels of residential institutions to Bhagwan Birsa Munda and other tribal freedom fighters on 15.11.2024.
- 2) Installing selfie points (as shared by the MoTA on its portal/website) for the students and staff to take selfies.
- 3) Organization of age-appropriate training/workshops on tribal art, dance, music, crafts, culture, contributions to Indian Society, especially in the freedom struggle and protection of environment.
- 4) Honoring of tribal achievers, including outstanding tribal scholars, who can serve as role models for the students.
- 5) Outreach activities to the tribal communities by students-such as involving in swatchata activities, plantation initiatives, each one teach one, enrolment in NSS/NCC/My Bharat.
- 6) Cultural events such as dance, drama, music, painting and other arts and crafts associated with tribal communities.
- 7) Quizzes on tribal freedom fighters, tribal culture and heritage, tribal crafts etc may be held.
- 8) Debates on role of participation of the leaders like Birsa Munda and other tribal leaders in freedom struggle.
- 9) Competitions:
 - a) Painting
 - b) Story writing
 - c) Poetry
 - d) Dance
 - e) Music
 - f) Drama
 - g) Nukkadnataks
 - h) Skits
 - i) Short write ups (250-500 words on the topic know my tribe/Tribal Freedom Fighters, Tribal Achievers, Tribal Languages etc.) and
 - j) Any other field as well as quizzes may be held on various aspects of tribal matters
 - k) Learning of Tribal Language and Tribals ways of Life.
 - l) Capacity Building of faculty may also be taken up. Training of Trainers & others may also be taken up.
- 10) Where the institution is a hostel or a residential one, at least one item in at least one of the daily meals during this period may be tribal recipe, so as to introduce the students to the culinary heritage.
- 11) Encouragement of POSHAN vaticas in the institutions, as well as plantation activities, including the adoption of tree by each student.




The list of activities to be conducted by all Departments/Schools/Centres during the celebration of Constitution Day on 26.11.2024

- 1) During this period activities including talks/Seminars emphasizing the importance of Constitution day, 'Reading of the Preamble' to imbibe the values and reaffirming our commitment to uphold its ideology, Quiz/Q&A Session/Essay writing Competitions, Painting/Poster making etc. may be organized.
- 2) Debate on role of women in preparation of Constitution & how Constitution was created.

Therefore, in view of the above, all the Heads of offices/Deans of School/Chairpersons of Special Centres are requested to kindly ensure the successful organization of these events as per the guidelines issued by the Ministry of Tribal Affairs & MoE through referred DO letters (attached). 

The Nodal Officer should also ensure the

conduct of these events and upload documentation on them on the portal of MoTA. Further, the nodal officer may also train school officials to upload the events conducted at the school on the portal.

Preservation and promotion of tribal culture would also be a significant part of the celebrations.
- iii. A calendar of activities for the period from 15.11.2024 to 26.11.2024 and from 26.11.2024 to 15.11.2025 may be got prepared. In the first instance, a calendar from 15.11.2024 to 26.11.2024 and upto 31.12.2024 may be prepared and sent to this Ministry by 2.11.2024. Thereafter, the entire year's calendar may be prepared and shared with this Ministry by 15.11.2024.
