**ORDER**

In compliance of Government of National Capital Territory of Delhi, Delhi Disaster Management Authority Order No. F/1. (589)/DDMA/(HQ)/Misc. Matters/COVID/21/373 dated 15.04.2021, wherein, the Chief Secretary, Delhi, has issued directions regarding **WEEKEND CURFEW** in the territory of NCT of Delhi from 10.00 P.M. on 16.04.2021 (Friday) to 05.00 A.M. on 19.04.2021 (Monday), except for essential activities/services, as an emergency measures for wellbeing and safety of people.

In view of above, the undersigned, in the capacity of the Registrar of the University hereby directs that weekend curfew will be in force in the University premises from 10.00 P.M. on 16.04.2021 (Friday) to 05.00 A.M. on 19.04.2021 (Monday), with immediate effect. However, there shall be no restrictions on movements of persons who are engaged for emergency services, Medical emergency and supply of goods during the curfew period on production of valid I-card. Persons coming from /going to Airport/ Railway station/ISBTs allowed to travel on production of valid ticket. Shops dealing with essential food, groceries, fruits and vegetables, diary and milk booth, pharmaceuticals and ATM are allowed to function. Whereas, all other shops, dhabas, canteens shall remain closed during the curfew timings.

Due to the weekend curfew announced by the Delhi government, Dr. B.R. Ambedkar Central Library will remain closed strictly from 08.00 P.M. on 16.04.2021 (Friday) to 09.00 A.M. on 19.04.2021 (Monday).

The Campus residents are hereby instructed that, the movement within the campus, and movement in and out of the campus shall be restricted during the curfew timings.

The Security Branch of the University is instructed to ensure strict compliance of this order, and shall adequately inform and sensitize the field functionaries about these instructions for strict compliance, in letter and spirit and all entry gates of the campus shall be closed in the curfew timings.

Anyone who violates the above directions and COVID-19 protocols, such violator(s) shall be liable for disciplinary action.
