With the approval of competent Authority, it has been decided that Research Excellence Awards are to be given in the areas of Science, Social Science & Humanities as per the following procedures:-

- 1. A new series of annual awards shall be initiated in JNU to recognize faculty members who have demonstrated their excellence in Science. Social Science & Humanities. The proposed awards will be called JNU Research Excellence Awards for the outstanding contribution of the JNU faculty members in their research areas.
- 2. In order to ensure the transparency and clarity, the following parameters will be adopted for selecting the awards.
 - a) <u>Originality</u>: What was the originality of thought that inspired the community? Was it incremental or substantial?
 - b) Quality: Standard assessment parameters shall be used to determine the quality work e.g., publication in national & International Journals/patent(s) awarded, citation, impact factor.
 - c) Impact: How much of impact has the work created in the scientific community and / or society? Can this work inspire the next generation of students / scientists?
- 3. The process for submission of applications for JNU Research Excellence Awards will be online on award section of the JNU website.
- 4. The award may consist of a certificate (bilingual), a shawl, memento, citation and life time free access to JNU library.
- 5. Awards may be given in the following categories:
 - I. <u>Young Scholar Award</u>-(up to 45 years). In the areas of Science. Humanities & Social Sciences (One in Science and one in Humanities & Social-Sciences).
 - II. <u>Eminent Scholars</u>: (Above 45 and upto 55 years). In the areas of Science. Humanities & Social Science (One in Science and one in Humanities & Social-Sciences).
 - III. Life Time Award- (Above 55 and upto 65 years). In the areas of Science, Humanities & Social Sciences (One in Science and one in Humanities & Social-Sciences).

6. General Instructions & Essential Information:-

- 1. Applicant should be the active regular faculty in JNU that includes UGC recharge faculty.
- II. The application form may have: Name/Age/Affiliation. Key Research Impact. key Societal Impact, Nominee details, Recommendations of the Head of the Concerned Department / Centre / School.
- III. The applicant may submit brief CV highlighting the Research, publications in National/International journals.
- IV. The award may be given on the 01st October every year coinciding with birthday anniversary of Dr. A.P.J.Abdul Kalam.
- V. Application should be submitted to SO (Project Admin Cell).

VI. Director R&D will constitute a committee to screen and finalize the application received for further necessary action.
