



AGREEMENT OF COOPERATION BETWEEN

SPECIAL CENTER FOR THE STUDY OF NORTH EAST INDIA
OF JAWAHARLAL NEHRU UNIVERSITY

AND

ARUN JAITLEY NATIONAL INSTITUTE OF FINANCIAL MANAGEMENT, MINISTRY
OF FINANCE, GOVERNMENT OF INDIA

The Special Center for the Study of North East India of Jawaharlal Nehru University (hereinafter called SCSNEI) and Arun Jaitley National Institute of Financial Management (hereinafter called AJNIFM) with the objective of promoting cooperation in education and academic research, conclude the following agreement of cooperation:

Article 1

Both parties hereby agree to promote the following activities so as to enhance each other's educational and academic roles and capabilities in the areas defined in Article 1.

1. Exchange of faculty
2. Exchange of research scholars and students
3. Exchange of information and materials in those fields that are of interest to both parties
4. Activities such as collaborative research, lectures and symposiums, etc
5. Joint Cultural Programmes

Article 2

The areas of focused activity shall be as follows, to begin with:

- a) The SCSNEI, in collaboration with AJNIFM, shall prepare reports on research and financial issues relating to the North Eastern States, covering aspects such as budgetary allocations and utilization, infrastructure financing, developmental challenges, fiscal management practices, implementation bottlenecks, regional economic disparities, and sector-specific policy concerns.
- b) Joint study and evidence-based policy research; preparation of technical and/or policy documents, identification of sector and theme-specific best practices relating to the North Eastern Region.



Article 3


All modalities pertaining to activities based on this AoC shall be negotiated and agreed upon between the two parties in each specific case.

Article 4

Unless agreed upon specifically, the host School/Department shall have no financial responsibility for any expenses incurred in respect of activities indicated above, other than those expressly provided for.

Article 5


The AoC shall remain effective for a period of two years from the date of signature. It may be further extended or amended with the written agreement of both parties. This AoC may be terminated by either party, subject to the delivery of six months' advance notice, in writing.
