Course outline

In America, ideological affiliation of judges is as important as partisan identification of voters. Political dynasties, churches, and labor unions influence voting behavior as much as issues like rising taxes, illegal immigration, and size of government. Respect for tradition and the demand for progress vie for legislative sanction on the floors of federal and state legislatures. A technologically advanced yet deeply devout society is protected by the most powerful military in the world. At the same time, a country that has strengthened the borders of its allies in various parts of the globe itself has porous borders.

Knowing how America perceives itself is key to understanding why it behaves in a certain manner with other nations and peoples. America was, and still is, a unique experiment in freedom and excellence. The efforts of every American down the ages have contributed to a collective greatness unheard of in human history. The efforts of every American today are still directed to the same goals.

This course attempts to explore how American society has kept changing over time, and how various social institutions have helped initiate that change. It also seeks to examine the relation between American society and American politics and how forces within American society try to influence politics to either facilitate or resist social change.

A modified version of a course with the same name taught earlier in the MPhil program, this course provides students with a wide choice of topics to work on for a doctoral degree in United States Studies. It is the second of the two advanced courses on American society, culture, and politics offered to PhD students as part of their coursework, and intends to provide them with a sound knowledge of society in America and how it worked in order to help them understand the United States and deal with it as policymakers, academics, and media persons, and even as storytellers and moviemakers.
