Introduction

This course will combine theory and practice by identifying specific methods used across social science disciplines, with some theoretical readings around each method. While CCPPT prioritizes a comparative method, this would be different from the conventional understanding of the comparative method as comparing across states or nations. Comparisons would rather be across disciplines, broad regions, cultures, intellectual traditions and so on.

Students are expected to do short research projects over the semester using some of the methods taught.
