This course intends to introduce students broadly to the United States as a society and to American ideas, institutions, culture, and social problems that are and continue to be typically American.

As important as how the world perceives America is the question of how Americans look at themselves and what measures they take—political, social, and economic—to preserve the United States as an "exceptional" nation in the post-modern world.

Classroom instruction will be directed to help students develop wide knowledge of America as a diverse and complex society with its own institutions and distinct culture, yet a "nation of immigrants" like no other. This course aims at giving students a "sense" of America, and at inculcating in them the understanding that politics in America is not merely a struggle for power but a concerted attempt to acquire freedom, equality, and justice for all Americans.
