COURSE OBJECTIVES:

The course will provide basic insights into the working of the global trading system with specific emphasis on the General Agreement on Tariffs and Trade (GATT)/World Trade Organization (WTO) regimes. The course primarily examines the GATT/WTO framework and its impact on India and other developing countries. The normative evolution of international trade law through the negotiations of GATT and later its implementation will form the core of the course. Subsequently, with the transformation of GATT into WTO brought into focus more complex regime of international trade law that includes elaborate and interpretative provisions relating to Most-Favoured Nation Treatment (MFN), National Treatment (NT), Safeguard Measures, Anti-dumping norms, prohibition of Quantitative Restrictions and subsidies, trade issues concerning developing countries, and settlement of trade disputes within the GATT/WTO system.

The course will focus on the attempts of the GATT system, despite it being dominatedby major trading countries, to bring about several improvements in its operation through various rounds of negotiations. The GATT mandate was to negotiate to bring down tariffs. However, over the years it has gone into many new areas framing new and broader trade regulatory frameworks. The course will examine these aspects. It will also examine the concerns of newly emerging developing countries. Although 'special and differential treatment' provisions were introduced to ameliorate the concerns of developing countries, they remain largely ineffective. The Uruguay Round of negotiations, launched in 1986 and eighth in the series of such rounds, brought about major changes. The Course will consider the institutional aspects of the World Trade Organization (WTO) as a permanent global trade institution and its role in international law-making. It is to be noted that besides the creation of the WTO, the Uruguay Round of negotiations brought on board several new issues into the negotiating agenda of the GATT/WTO system such as intellectual property rights, investments and services. The GATT system which was hitherto primarily concerned with thetariff reduction of goods that are being either exported or imported, now with the advent of WTO, the new norms sought to regulate several new areas in international trade law. With the rapid development of technology in several areas the nature and functioning of international trade also transformed. Considering the range of topics and the interpretative techniques used in its dispute settlement process the relevance and reach of WTO has increased manifold. The rapid process of globalization also created the conditions for the dominant role for the WTO in global trade affairs. Therefore, the course will also deal with contemporary concerns that are debated and dealt within the WTO.

LEARNING OUTCOMES:

The course will seek to equip the PhD students with basic understanding of the legal and institutional framework of the GATT/WTO regime. It will also provide various perspectives about the nature and working of the GATT/WTO. It will include the basic principles and standards that form part of the international trade regime, in particular within the context of the WTO. The focus on domestic regulatory frameworks relating to international trade law, in particular the Indian legal framework, will help the students understand the role of nodal Ministries such as Ministry of Commerce as well as Ministry of External Affairs. The study of various negotiating formats in the area of international trade law will help students to understand and contribute to the work of not only the Government, but also the private sector and the civil society.
