Course Objective:

The course familiarizes students to theoretical frameworks for comparative analysis and examines the evolution of health services in China. The two Asian giants represent variation in historical and socio-political contexts in which health and health service systems have evolved. The experience of China will be compared and contrasted with the Indian experience.

Course Outline:

This course is divided into three sections. The first section provides a theoretical overview on comparative studies. The second section provides a historical and political overview of the evolution of health services and determinants of health in China and India. The third section focuses on the shifts in health service development, health sector reforms and its implication for universality and equity.
