## **Conditions:**-

- 1. Earnest Money amounting to Rs.1227/- should be deposited in the shape of Pay Order/Banker's Cheque/Demand Draft in favour Finance Officer, JNU. No quotation will be entertained without Earnest Money.
- 2. The firm has to submit self-attested copies of all relevant documents such as PAN no., GST Registration, Authorized Dealership Certificate and Experience Certificate and original EMD in the shape of Pay Order / Bankers Cheque / Demand Draft in a separate envelope along with the quotation mentioning name of work & due date of opening on the envelope.
- 3. The price bid shall be placed in separate sealed envelope marked "Price Bid" which shall be mentioned with the name of work and due date of opening written on envelope.
- 4. The quotation for the work shall remain open for a period of 45 days from the date of opening of quotations. The EMD amount shall be forfeited absolutely if contractor back out from the bid before validation period.
- 5. Security deposit @7.5% of quoted amount shall be recovered from the bills paid to the agency and the same shall be refunded after warranty period of six months.
- 6. The contractor should quote rate after inspecting nature of work required to be carried out at sites.

14. Payment shall be made on half yearly basis after satisfactory services by the agency.
