- 6. The Quotation and the earnest money shall be placed in separate sealed envelopes, each marked, "Quotation" and "Earnest Money" respectively. Both the envelopes shall be submitted together in another sealed envelope with the name of work and due date of opening written on envelope. The envelopes marked, "Quotation" of only those Quotationers shall be opened, whose earnest money, placed in the other envelope, is found to be in order.
- 7. Time allowed for completion of above work shall be 30 Days which shall be reckoned from the date of issue of order to commence the work.
- 8. The firm has to produce attested copies of all relevant documents such as registration in Govt. department, PAN no., and GST no., etc. along with quotation.
- 9. No extra cartage will be paid.
